MEMBERSHIP TERMS & CONDITIONS

Definitions

A **MEMBERSHIP** grants member(s) access to specific Geneseo Park District amenities. The member(s) is obligated to pay dues whether the member(s) accesses the amenities or not. All memberships expire at the end of the month regardless of purchase date.

MEMBERSHIP ACCESS: A **COMMUNITY CENTER** membership grants access to the Cardio/Weight room, Indoor Pool, Walking/Running Track, Basketball and Racquetball courts. An **OUTDOOR POOL** membership grants access to the outdoor pool. A **PARK DISTRICT** membership grants access to both the Community Center and Outdoor Pool amenities.

MEMBERSHIP TYPES: A **HOUSEHOLD** is defined as any two individuals residing at the same address. Individuals are categorized in the following age ranges: **YOUTH** (6 months – 18 yrs) ; **ADULT** (19 yrs-64 yrs) ; **SENIOR** (65 yrs & older)

A **NON-RESIDENT** is an individual who neither resides within the corporate boundaries of the Geneseo Park District nor pays taxes for the Geneseo Park District . A \$50 annual non-resident fee will be applied to membership purchases or renewals.

BUSINESS DISCOUNTS: Businesses participating in this program pay an annual non-refundable fee for their employees to benefit from a discount on the membership of their choice. The amount is \$300 for a 10% discount. Proof of current employment and a photo ID must be presented for a business discount to be applied. Only one business discount can be applied to a membership price and the employee must be included in that membership. The discount percentage is applied to the base price of annual memberships only. Only after the discount has been applied are service fees, non-resident fees, and locker fees added in to the total amount to be paid. Business discounts cannot be used for 6 month or 1 month memberships. No adjustments will be made for existing memberships, only at renewal or upgrade.

Payment Plan Information

1 PAY: The 1pay plan consists of paying the full amount owed at time of purchase or renewal. Available for all membership types.

3 PAY: The 3pay plan consists of 3 consecutive monthly payments paid the first three months of your membership. The membership price including a \$10 setup fee, applicable non-resident and/or locker fees, less business/employee discounts and is divided into 3 equal payments. A \$5 service will be charged on payments received after the due date. Available for annual Community Center or Park District memberships only.

12 PAY: The 12pay plan is the only way that the Geneseo Park District can accept monthly payments for annual Community Center or Park District membership dues. The membership price including service fees (\$2/month), non-resident and/or locker fees is divided by 12 to arrive at the monthly payment. An initial down payment is required at time of purchase, fulfilling your first and last month's payment obligation. The monthly payment will be automatically deducted from the member(s) bank account for a minimum of 10 consecutive months. Anytime after the 10 months, a member may cancel the payment plan provided a written notice is received by the Geneseo Park District 30 days prior to cancellation. Member(s) may complete and sign a 12pay cancellation form or submit a letter authorizing the Geneseo Park District and respective bank to stop processing the monthly withdrawal. Members with insufficient funds in their bank account will have the past due payments included with the following month's current payment amount. Memberships will be suspended after a second insufficient fund error until past due balances are paid in full.

PAST DUE PAYMENTS: The member(s) will be liable for payment of all costs incurred by the Geneseo Park District to collect past due obligations. Future memberships cannot be obtained until household balances are paid in full.

BINDING CONTRACT: This agreement represents the complete understanding between the member(s) and the Geneseo Park District. No representations, written or oral, other than those contained within this agreement are authorized by or binding upon the Geneseo Park District.

REFUND POLICY: annual memberships discontinued prior to the expiration date will be refunded 50% of the unused balance less a \$5.00 service fee.

UPGRADE POLICY: the upgrade calculation grants 100% credit of the unused portion on the existing membership and is deducted from the new membership price. A new expiration date is established at the time of upgrade. New payment plan forms will be completed at this time.

Memberships are **NOT TRANSFERABLE**.

PHOTO WAIVER: The Park District occasionally takes photographs or video of participants for promoting/advertising our programs, services, events, activities, and facilities in our brochures, website or agency social media, and other promotional avenues. By registering for, participating in or attending Park District programs, events, or other activities, the participant (or parent/guardian of a minor participant) irrevocably agrees to the use and distribution by the Park District of his or her image (or of his minor child/ward) in photographs, video recordings, and any other electronic reproductions of such programs, events and activities for any purpose without inspection or approval and without compensation, rights to royalties or any other consideration now and in the future. If you do not wish your household to be photographed you will need to complete and sign the Geneseo Park District Photo Waiver form.

EMAIL DISTRIBUTION LISTS: You will be automatically signed up for the Geneseo Park District member email list. You will have the opportunity to join other interest-specific lists or opt-out altogether upon receiving the first email.
